The SACD is a non-profit collective management organization that does not commercially exploit your data.

<u>Data Controller:</u> SACD (11bis rue Ballu, 75009 Paris, France) <u>Purpose (and its basis)</u>: collection and distribution of royalties and other author's fees (Statutes of the SACD)

Recipients of the data: within the limits of their respective powers, duly authorised SACD staff, other collective management bodies located in and outside the European Union with which the SACD has signed representation agreements.

Instructions

The distribution of series creators' royalties is done on a 100% basis, and must be the object of a mutual agreement between all of the beneficiaries. The applicable distribution breakdown keys will be those voted upon by the Board of Directors (see definition of the bible).

For live-action series, the literary bible royalties are:

- for original series: 10% maximum of the text share,
- for adaptations of a pre-existing work: 10% maximum of the adaptation's share.

For animation series, the bible share (literary and graphic) is deducted and distributed before the share-out between screenwriters and directors.

For original series:

literary and graphic bible: 12 %

- literary bible only: 8,5 %

- graphic bible only: 8,5 %

For adaptations of a pre-existing work:

- literary and graphic bible: 10 %

literary bible only: 8 %

- graphic bible only: 8 %

The share is done by mutual agreement between the authors of the literary bible and the graphic bible. In case of lack of an agreement in the six months following the broadcast of the work, the share will be 50/50 between the literary bible and the graphic bible.
